**DISCLAIMER** Hello Everyone. Today is Saturday, October 24, 2020. Welcome to our Contract Trust Conference Call. We are not accountants, tax professionals, lawyers or currency dealers. **WELCOME** Thanks for joining us today. My name is Carol Werelius and my associate Jim Knox and I have these calls every 2<sup>nd</sup> and 4<sup>th</sup> Saturday of the month. These calls are recorded and available on our website, [www.indicator information.com](http://www.indicatorinformation.com), [iqdcalls.com](http://iqdcalls.com) and YouTube. As we get closer and closer to our expected event, we thought this would be a good time to review our Common Law Contract Trust, and why we think it is the best vehicle for you to protect your assets. As always, your questions are welcome. \*6 to raise your hand.

We are going to change things up a bit today. We will be doing Q & A for most of the call, so please have your questions about Trusts ready. We will NOT be taking questions about the event, as we really don't know much more than you do. That being said, we would like to reiterate some of the things we have recently heard.

1. **\*\*\*Keep it Quiet!!!\*\*\***A new communications monitoring system of Social Media posts, Emails, Text messages, Discord DMs, phone conversations, etc. was in effect by the NSA and military Intel (DIA). The Intel Contact reported that you needed to be quiet about Global Currency Reset and RV related issues, especially from the time you called the 800# and set your appointment. In order to set that appointment, you would be required to sign a Non-Disclosure Agreement. From the time you called the 800# through at least the 90-day NDA period following exchanges/ redemption, everything you write or say about the RV/GCR would be heard by the new

communications monitoring system to determine if you broke conditions of that NDA. If so, your monies could be frozen.

2. We have read that Wells Fargo, Chase and HSBC banks would be sending out emails with a Safe Link Website that contained an individual 800#, which you could use to set your exchange/ redemption appointment. If you did not receive an email, then you could find the Secure Website on the websites as below. That Secured Website would have instructions on how to obtain your personalized coded 800# ID number for the redemption process. The Safe Link Website where you may obtain your own 800# would be on these links:

9. Click on the Safe Website and put in the zip code in which you live or in which you want to exchange / redeem. After you log into the Safe Link Website you will be asked some qualifying questions that tells them whom you are (like when you open a bank account). That would then generate an 800 number based on what location you put in. A unique code would be generated with the 800# for each currency holder and that code would be your unique ID code for your appointment. Those who used the general 800# from Intel sites would be given their unique code from the Call Center representatives. If you have Zim, tell them so they can direct you to the right Redemption Center. They want Zim redeemers in the first four days. The Redemption Centers would be closed after 30 days. In addition to the 800 Number you would receive a Non-Disclosure Agreement (NDA) that you needed to agree with and return. There would be a second NDA for you to sign at your appointment. From that point onward you could not discuss anything about your appointment, nor the reset, to anyone for 90 days.
10. We **may** send a email blast announcing that the eagle has landed, or something to that effect.

11. I know we have discussed this in the past, but as a reminder, there are certain words and terms you cannot use at your exchange or violate your NDA after the exchange. .....Redemption, Exchange, Global Currency Reset (GCR), Revaluation (RV) ,Currency exchange rates , Quantum Financial System (QFS). Do not use these terms after you exchange and sign an NDA.
12. Now to Q & A.
